

**Broadscope Disability Services’
Virtual Trivia Game Contest**

OFFICIAL RULES

Broadscope Disability Services’ Virtual Trivia Game Contest (the “Contest”) is a skill-based contest; this is not a game of chance. Winners will be chosen based on the stated criteria. By entering (or otherwise participating) in the Contest, you agree to these Official Rules, so please read them carefully before entering.

The Contest benefits Broadscope Disability Services, a 501(c)(3), not-for-profit organization dedicated to providing respite, employment, independent living, and other programs, services, and resources for people and families living with disabilities.

PLEASE NOTE: Because of the ongoing impact of COVID-19, Broadscope Disability Services’ Virtual Trivia Game Contest (the “Contest”) is being offered virtually this year. Sponsor is not liable for any electronic failures in connection with this Contest, including but not limited to technical or software failures of any kind; lost, interrupted, or slow network connections; or failed, incomplete, or delayed computer transmissions. By participating in the Contest, contestants accept the risk that such technical malfunctions, connectivity issues, and Internet speed-related issues may limit a contestant’s ability to participate in the games, including but not limited to preventing a contestant from hearing, seeing, or submitting a timely response to a question. If such technical issues occur on the Sponsor’s end, the Sponsor retains the right to throw out a question and choose another question, or take any other reasonable action that, in Sponsor’s sole judgment and discretion, Sponsor believes will maintain the fair play and integrity of the games. No claims made by contestants relating to such technical issues will be honored or considered except in the sole discretion of the Sponsor.

ELIGIBILITY: The Contest is open to legal U.S. residents physically residing in the 50 United States (including D.C.; excluding AZ) who are at least fifteen (15) years of age or older. (Please note that participants under 18 years of age must obtain parental consent before participating in the Contest.)

EVENT DATE, LOCATION, ENTRY FEES, AND REGISTRATION: The Contest will take place on Thursday, March 10, 2022, from 7:00 p.m. Central Time (CT) to 8:00 p.m. CT. Upon registering, contestants will receive a Zoom link to the Contest, which will be accessible at least 15 minutes prior to the Contest start time. The Zoom link to the Contest will be accessible only to contestants.

The Contest will be a team-based event (though, as noted below, prizes will also be awarded to the highest performing individuals overall). Teams will be made up of a minimum of two contestants and a maximum of 8 contestants. At the time of registration, contestants will be able to identify the team on which they will be participating.

Individuals who would like to participate but do not sign up as part of a team (or do not have a team) are encouraged to still sign up. Such individuals will be organized into 4-person teams of other individual contestants by Sponsor, based on the order in which they register. In the event that there are either two or three individuals remaining after forming the 4-person teams of individuals, the remaining individuals will form their own team of 2 or 3 contestants, respectively. If one individual remains after forming the 4-person teams of individuals, this individual will be added to the last formed 4-person team to create a 5-person team.

To register for the Contest, please go to <https://broadscope.wedoauctions.com> and follow the instructions found there. The fee to enter the Contest is \$25 per person. Contest entry will also be given to those people who register for the Contest-plus-Tasting Package (\$75 per person) and those who register as part of a

sponsorship package. Additional instructions regarding when and how to access the Contest will be provided to contestants following registration.

GAME PLAY AND SELECTION OF WINNERS: The judge(s) will consist of a person or panel selected by the Sponsor and/or the Sponsor's designees. Decisions by the judge(s) will be final in all matters relating to the Contest, including interpretation of these Official Rules and the awarding of prizes. All contestants, as a condition of entry, agree to be bound by these Official Rules and the decisions of the judge(s).

I. **The Contest will take place on two platforms: Zoom and Crowd.Live.**

Thus, contestants will need two Internet-connected devices to participate in the Contest. Specifically, questions will be read out loud and displayed on Zoom. (Each registered contestant will receive an email with the Zoom login link and password.) Contestants will then answer questions by using Crowd.Live on a second device. (Each registered contestant will receive an email with a Crowd.Live link and password.)

For example, a common set-up is to use a personal computer logged in to Zoom, and a phone logged into Crowd.Live. A contestant can use her personal computer to view the questions as they appear on the Zoom screen. Once a question is displayed, the contestant can then use her phone to choose the correct (multiple-choice) answer displayed on Crowd.Live.

- II. All contestants are asked to log in to the Zoom call 10 minutes prior to the Contest start-time. (*Helpful Hint:* Make sure that your devices are fully charged or plugged in before starting the game, as video conferencing uses lots of battery power.)
- III. The Contest will consist of 5 rounds of 10 questions.
- IV. Contestants are given 20 seconds to click on the correct answer on Crowd.Live. The 20-second countdown will be shown on the Zoom screen, or will be counted by a judge using a timing device.

- V. Each question is initially worth 100 points, and the points will begin to decrease as time counts down. Individual contestants' scores decrease 5 points every second and can be calculated by the millisecond.
- VI. A contestant who correctly answers the question will have the indicated points added to his/her total points. A team's score is calculated by averaging the scores of all the contestants on that team.
- VII. In the unlikely event of a tie (either individual or team), another question will be asked of only those contestants who are tied. The question will be selected by the host from a list of "extra" questions. The contestant/team that receives the highest score will be named the winner. All contestants are permitted to remain on the Zoom call during the tie breaker question(s), but are asked not to participate.
- VIII. If there is any interference during a question (in the sole discretion and determination of the judge(s)), that question will be thrown out and the host will select a question from the set of "extra" questions. PLEASE NOTE: Broadscope Disability Services reserves the right to eject anyone who interferes with the game or acts inappropriately, without refund.
- IX. At the end of the game, the judge(s) will tally the scores and the team and individual winners will be announced while contestants are still on the Zoom call.

Please Note: The Contest is a family-friendly function. Rude or offensive language, clothing, or other visuals, or any attempts to interrupt the Contest, are not permitted. Any such behavior could result in the immediate dismissal of the contestant with no refund.

PRIZES AND APPROXIMATE RETAIL VALUES (ARV): Prizes will be awarded to each of the contestants on the top three highest scoring teams, as well as the top three highest scoring individuals. Specifically, the winners will receive the corresponding prizes below:

I. Team Prizes

- 1st place team (each member): \$50 Amazon gift card (ARV: \$50.)
- 2nd place team (each member): \$25 Amazon gift card (ARV: \$25.)
- 3rd place team (each member): \$10 Amazon gift card (ARV: \$10.)

II. Individual Prizes

- 1st place Individual: \$100 Amazon gift card (ARV: \$100.)
- 2nd place individual: \$50 Amazon gift card (ARV: \$50.)
- 3rd place individual: \$25 Amazon gift card (ARV: \$25.)

Prizes will be mailed to winners by March 30, 2022 using the information provided at the time of registration. Please note that if a winner is a minor (i.e., under 18 years of age), the prize will be awarded to the minor's parent/legal guardian on behalf of the minor. Sponsor reserves the right to substitute a prize of equal approximate retail value if the stated prizes become unavailable for any reason, including but not limited to issues or restrictions relating to the COVID-19 pandemic. No substitution or cash equivalent allowed, except in the sole discretion of the Sponsor. All other costs and expenses not specified herein related to any prize are the sole responsibility of the winner.

LEGAL: The Contest is subject to all applicable federal, state, and local laws and regulations. Void where prohibited or restricted by law or regulations. Odds of winning depend on the number of contestants and the ability of the contestants to correctly answer trivia questions.

Sponsor reserves the right to disqualify from the Contest any contestant that, in Sponsor's sole discretion, engages in poor sportsmanship, displays inappropriate behavior, fails to follow Sponsor's instructions, or acts in any way that reflects negatively upon the Sponsor or the Contest.

Taxes. Winner is solely responsible for all federal, state, and local taxes on prize.

Publicity Release. Except where prohibited, Contest registration constitutes contestant's consent that his or her name, likeness, voice and/or biographical data may be used for advertising and promotional purposes without limitation and without additional notice, compensation, or consent. Submission of content to be posted online constitutes permission for same, and participant consents to the recording of the Contest and that recording being made available for public viewing.

Release. By entering, contestant agrees to accept and abide by the Official Rules of this Contest and agrees that any dispute with regard to the conduct of this

Contest, rule interpretation, or award of prize shall be submitted to Sponsor, whose decision shall be binding and final. By participating, you release Sponsor and its respective subsidiaries, affiliates, partners, employees, directors, and agents from any and against any and all injury, loss or damage including but not limited to, personal injury, death or damage to or loss of property, caused or claimed to be caused by your participation in the Contest.

Miscellaneous. Sponsor is not responsible for any typographical or other error in the printing of this offer, administration of the Contest, or in the announcement of prizes, including erroneous appearance of qualification for a prize, and under no circumstances will more than the stated number of prizes be awarded. As stated more fully above, Sponsor is not responsible for any technical issues, including but not limited to technical issues that may prevent a contestant from hearing, seeing, or responding to a question. If technical issues occur on the Sponsor's end, the Sponsor may, at its sole discretion, throw out the question and choose a new question. Sponsor reserves the right, in its sole and absolute discretion, to modify, cancel, or suspend this Contest, or to amend the Official Rules at any time, without prior individual notice, should any factor interfere with the administration, security, or proper play of this Contest as contemplated by these Official Rules. If for any reason Sponsor is prevented from continuing with this Contest, or the integrity and/or feasibility of the Contest is severely undermined by any event including but not limited to cancellation of the event, fire, flood, epidemic, pandemic, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, war (declared or undeclared), terrorist threat or activity, or any federal, state or local government law, order or regulation, order of any court or jurisdiction, Sponsor shall have the right, in its sole discretion, to abbreviate, modify, suspend, cancel or terminate the Contest without further obligation. If Sponsor in its discretion elects to so abbreviate the Contest, Sponsor reserves the right, but not the obligation, to award the prize from among all contestants participating to date.

DISPUTES / CHOICE OF LAW. EXCEPT WHERE PROHIBITED, EACH ENTRANT AGREES THAT: (1) ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION

ARISING OUT OF OR CONNECTED WITH THIS CONTEST OR ANY PRIZE AWARDED SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION, AND EXCLUSIVELY BY STATE OR FEDERAL COURTS SITUATED IN WISCONSIN, (2) ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS INCURRED, BUT IN NO EVENT ATTORNEYS' FEES, (3) NO PUNITIVE, INCIDENTAL, SPECIAL, CONSEQUENTIAL OR OTHER DAMAGES, INCLUDING, WITHOUT LIMITATION, LOST PROFITS, MAY BE AWARDED (COLLECTIVELY, "SPECIAL DAMAGES"), AND (4) ENTRANT HEREBY WAIVES ALL RIGHTS TO CLAIM SPECIAL DAMAGES AND ALL RIGHTS TO SUCH DAMAGES MULTIPLIED OR INCREASED.
